

Sentencing Data - Centralized and Simplified

In order to maintain a "consistent and rational statewide sentencing policy," the Pennsylvania Commission on Sentencing (PCS) adopted sentencing guidelines, providing judges with a common reference point for sentencing.

Although a step toward greater equity and fairness, this also led to great confusion - as of January 2001, the PCS data collection process involved two separate software applications, one centralized database, and many distributed, stand-alone databases. Much of the data was printed from the applications and mailed to PCS, which then had to re-key the data from the paper forms. This was not only time-consuming; it was error-prone, and impractical, as reports were typically available from this system only at the end of each year. Enter Cross Current Corporation.


